Notification of Yum China Supplier CSR Audit July, 2023

Dear Suppliers,

Yum China is committed to driving responsible sourcing practices and building a responsible supply chain in collaboration with our supplier partners. We require the suppliers to take responsibility for their employees, customers, communities and environment, in addition to profit making and legal obligations for their shareholders. Subject to the existing laws and regulations, the suppliers should also emphasize the human values throughout production and the contribution to environment, customers and society. Therefore, it is our suppliers' responsibility to be assessed by Corporate Social Responsibility (CSR) audit. The framework and evaluation criteria of CSR audit are approved and endorsed by Yum China Chief Supply Chain Officer and Sustainability Committee.

Yum China engages the third party auditing firms to carry out the CSR audit which is tailored to manage the suppliers.

- 1. Audit scope:
  - 1) Attendance records and payrolls kept for the last 12 months, health & safety system documents, system maintenance documents and records etc.
- 2) All the facilities under the same factory boundary or business license.

### 2. Audit contents:

1) Audit framework and evaluation criteria are developed with reference to applicable national laws and regulations and international standards.

# 3. Audit preparation

The auditing firms and the suppliers make an agreement on audit date and time. The
detailed audit preparation and procedure are provided by the auditing firms to the
suppliers in written form.

## 4. CSR program training

 In order to help suppliers understand Yum China's CSR Audit Program, training sessions are provided. Suppliers are encouraged to join the training and take continuous efforts to enhance own management system.

## 5. Audit result and period of validity

- The audit report is available in 5 working days after the audit is completed. The grading A,
   B or C is generated based on the severity of the issues identified through auditing.
- 2) Grade A: The supplier is audited every 24 months.
  Grade B: The supplier is audited every 12 months and should take corrective actions on non-compliance issues
  - Grade C: The supplier must take immediate corrective actions and undergo a follow-up audit.
- 3) If the follow-up audit is still graded C, Yum China will carefully review the partnership with the supplier.

## 6. Corrective and prevention Action Plans (CAPAP)

 After receiving a rating based on non-compliance issues identified during the audit, suppliers are required to submit detailed corrective and preventive action plans (CAPAP) for continuous improvement.
